

## **Stakeholder Input: OBC Poverty Reduction Policy Concepts**

During October of 2014, the Oregon Business Council (OBC) and the Oregon Prosperity Agenda, with support of the Federal Reserve Bank of San Francisco, United Way of Columbia-Willamette, and The Ford Family Foundation, facilitated eight Stakeholder Forums throughout Oregon. Combined, over 360 signed up and were asked to provide input on a number of policy concepts developed by the OBC Anti-Poverty Task Force.

Attendees were asked to discuss and rank the top three policies in each column they think would have the largest impact in reducing poverty in Oregon by year 2020 and to provide additional ideas. Those policies highlighted in light blue below received by far the most support among the stakeholders. Additional input was documented and summarized in the order of how often they were mentioned. We are grateful for the time and commitment by all who engaged at the forums!

Expand new-parent interventions (e.g., Nurse- Family Partnership; InfantNet)	Create rural Oregon jobs by improving forest health and biomass use	Expand tax credits for Individual Development Accounts (IDAs)

Create financial incentives for high schools and colleges to produce graduates with technical certificates in high-demand, good-wage fields	Support the growth of manufacturing industries that provide good-paying jobs for people w/o 4-year degrees	Reform TANF: increase gross income limit, index benefit, tailor program to individual circumstances and local economic conditions
Expand apprenticeship programs and opportunities (e.g., Career Academies in high schools)	Expand summer employment opportunities for low-income youth who are enrolled in school or are recent HS graduates	Expand State EITC: double credit for children under age 6; expand for childless workers; reduce marriage penalties
Provide free FAFSA assistance to low-income students during tax preparation season	Invest in infrastructure projects (i.e. transportation, water, energy) that lay the foundation for long-term growth and create construction jobs today	Expand Employment Related Day Care (ERDC) program to improve the transition from safety net to work
Expand Oregon Opportunity Grant and prioritize funding for pipeline of high school graduates		Create/expand targeted tax credits (e.g., senior, disability, transportation) for low-income households
Expand community-based mentoring programs (e.g., Friends of the Children; Big Brothers Big Sisters)		
Expand college-going support programs (e.g., College Possible, College Dreams, etc.)		
Overhaul college remediation services by improving placement, providing better service, and adopting preventative measures		

## Additional comments on listed items/topics/suggestions for other policies or actions (in rough order of degree of support measured by the number of time they were mentioned):

- Critical need for affordable housing & workforce housing
- Raise minimum wage
- Create and require life/soft skill training including financial literacy in K-12
- Create access to affordable childcare
- Expand infrastructure (esp.: internet access) to central/eastern Oregon
- Incentivize personal responsibility/accountability
- Responsible use of natural resources
- Wage equity/disparity (gender & minority) racial justice
- Expand tax credits for low income housing
- Reform overall safety net not expand
- Require TANF recipients to connect with workforce/education- make work pay ROI- incentivize employment over welfare
